[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

[Note: The only record relating to this veteran in the federal pension files is the Bounty Land Warrant Record Card which indicates that Edward Monday, private in the Virginia service received a warrant for 100 acres of land December 13, 1791 which warrant was actually issued to Francis Graves, assignee.]

The subjoined authority from Mrs. Martha A. Rose (one of the heirs of Edward Monday, who was a soldier in the Continental line in the Revolutionary War) is my Warrant for now asking of the Honorable the Executive of Virginia, land Bounty for his services –

The proof of the service of Edward Monday, for at least three years, is to be found in the Auditor's Certificate here with file, and which shows that he received "£102.3.10, for services prior to first January 1782." The pay of a soldier of Infantry was \$8 a month, or \$96 per annum so that, the pay for three years services would amount to \$288 – Now E. Monday received \$340 and upwards and was paid him only "for services" – it must be therefore manifest, that he served more than three years and is entitled to Land bounty for that time certainly – It is most respectfully asked that his heirs may be allowed whatever your Honorable body may deem just & right

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 4<sup>th</sup> day of August 1783, in the name of Edward Monday, as a soldier of Infantry for £102.3.10, which Certificate appears to have been delivered to himself and was given for services prior to the 1<sup>st</sup> January 1782.

Given under my hand, at the Auditor's Office, Richmond, this  
9<sup>th</sup> day of December 1838.
