The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## [From bounty land records in the Library of Virginia]

## To his Excellency the Governor of Virginia

The Memorial of Charles Kent of the County of North. [sic] humbly represents that he is the only child of John Kent, who was the brother to Joshua Kent of said County. That said Joshua was a Seaman in the Navy during the Revolutionary War as your memorialist is informed enlisted in the Navy for three years which time he served honorably, discharged under whom he [indecipherable word]. Your memorialist has not been able to ascertain but has been informed he served the first part of [indecipherable word] on board of the Ship *Tempest* Captain Callender [Eleazer Callender] & was probably on board of the *Tempest* [under] Captain Saunders [Celey Saunders] part of the time. Your memorialist hopes from the documentary evidence [indecipherable word or words] supported by that of a living witness that his case may be allowed. The said Joshua died without issue & left John his only brother, who also died with no other issue than your memorialist. Given under my hand this 13<sup>th</sup> October 18?? [Last 2 digits indecipherable]

Upon the Petition of the heirs of Joshua Kent a Seaman in the State Navy, for bounty land No proof of this claim has been offered by the Petitioner but he has spoken in his petition of the testimony of a living witness.

Joshua Kent's name is on a [indecipherable word] of men of the *Tempest* in December 1779 (see Papers of the Tempest – Volume first Navy Papers)

He was in the *Dragon* – September 10<sup>th</sup> 1778 (see Navy Journal – page 470)

His name is on the Army register. [Indecipherable word or words] – April 18<sup>th</sup> 1784 £56.15.11 the last [indecipherable word] pay: the certification for [the balance of this document is basically illegible as posted online. If anyone has a transcript of this document which they are willing to share with us for posting in this database, it would be greatly appreciated.] [This is the report given by John H Smith, Commissioner to Governor Tazewell of Virginia.]
