

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

Soldier in the Virginia Line is furloughed until called for by proper Authority, Given at Point of  
Fork 12th September 1783

Certify that George Paire was a Soldier enlisted for the War prior to the 1st January 1782 &  
continued in service to the end thereof.

For value received I do assign to William Reynolds the Gratuity & full balance of pay due me as  
a Soldier of the Virginia line who enlisted for the War prior to January 1782 and served to the  
end thereof which Claim I warrant & oblige myself to make good to said Reynolds.
