## Bounty Land Warrant information relating to William Ham VAS1364 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

These are to Certifie that the Bearer hereof Wm Ham has Served as a Seaman in the Navy of this State upwards of three years.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers

of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 22<sup>nd</sup> day of April 1785, in the name of William Hand, as a Seaman for £62.2.9, which Certificate appears to have been delivered to Jones Allen and was given for services prior to the 1<sup>st</sup> January 1782.

Given under my hand, at the Auditor's Office, Richmond, this 16<sup>th</sup> day of June, 1837.

I, James Barron do certify that I was intimately acquainted with William Ham of Elizabeth City County Virginia – that at a very early age and some years before the Revolutionary War ended, he entered the Naval Service of Virginia, as a lad [indecipherable word] he afterwards became a master's mate, and then a Lieutenant, and that he commanded the Schooner *Nicholson* on the James River engaged in transporting provisions from its various branches to Trebel's [Trebell's Landing, 6 miles west of Yorktown] landing for the use of the Army at the siege of Yorktown in 1781 = that after the Siege of Yorktown most of the vessels were sold or dismantled and many of their officers discharged = [indecipherable word] that Captain Ham continued in the service of Virginia as a Lieutenant until the end of the War. Lieutenant Ham in consequence of his zeal and patriotic conduct was a favorite of my Father's and was [indecipherable word] in his family. My father was associated with Colonel Pickering Commissary General of the Continental Army, and they had their head quarters at Trebel's Landing, and of course had Lieutenant Ham under his eye during that trying time. I can state the foregoing facts as being with in my own personal knowledge.

The Affidavit of James Webb taken this 4<sup>th</sup> day of September in the year 1837 before me William Hope a Notary Public in and for the County of Elizabeth City State of Virginia who being duly sworn deposeth and saith that he was intimately acquainted with the late Captain William Ham, that he entered the service in the Revolutionary War very young, that at one time he commanded one of the State Boats, that said Ham he always understood continued in the service till the close of the war, and further this Affiant saith not.
