[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

At a Court held for Bedford County at the Courthouse the 25th day of September 1826

It appearing to the satisfaction of the Court that Aggittia Hix [Agatha Hix] is the heir at law of David Hix a deceased officer of the Virginia line on Continental Establishment – which is ordered to be certified



William Drake¹ aged 70 years being duly sworn according to law deposeth and saith that David Hix was a Lieutenant in Captain [name too faint to discern] company in the seventh Regiment on Continental establishment & commanded by Colonel Hawes [Samuel Hawes]. The deponent further says that he (this deponent) was [word too faint to discern] from the 3rd Regiment of light dragoons commanded by Colonel Anthony W White in the fall of 1780 and was attached to the 7th Regiment of Infantry from which services he was acquainted with said Lieutenant Hix until the battle of [words too faint to discern], and further saith not

State of Virginia Bedford County Sct.

John Thomasson aged 80 one years being duly sworn according to law deposeth and saith that David Hix received a Lieutenant's commission in the spring of the year 1780 and entered the Army for the term of [several lines of text too faint to discern] in the 7th Regiment commanded by Colonel Hawes [several lines of text too faint to discern] March 1781 [several lines of text too faint to discern] in the battle fought at Guilford Courthouse in the State of North Carolina the
