Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Governor of Virginia

The petition of William E Beeson for himself and the other heirs of Lieutenant John Humphries

That in the latter part of the summer of 1775 he was a Lieutenant of the Virginia Continental line and subsequently marched to Québec and was killed by the side of General Montgomery on 31 December 1775 while storming Québec.

In 1783 his heirs were delivered 2666 2/3 acres for his services as an officer in the Virginia Continental line for three years. Besides the evidence then filed, "The American State Papers" title "Claims" page 72, show he was a Virginia officer & killed before Québec. 1


