[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Essex [County Virginia] SS Thomas May¹ of King & Queen County a Soldier in the Revolutionary War personally appeared before me & being examined on oath declares that John Hutchson of Caroline County, he knows to have enlisted under Captain Haws for three years, & then enlisted after the three years expired in Colonel Lee's [Henry "Light Horse Harry" Lee's] Horse during the War & served his time out – Given under my hand this 31st day of July 1813

It appears by the books of this Office, that a military Land bounty warrant for 100 acres issued to Thomas M. Bayly assignee of the representative of John Hutchison in consideration of the services of the said John Hutchison as a private for 3 years in the Continental line of agreeably to a certificate of Council bearing date the 17th of September 1807.

Also a military Land bounty warrant for 100 acres issued to John Hutchenson, in consideration of his services as a private for 3 years in the State line agreeably to a certificate of Council, bearing date the 1st of September 1786.

By the Books in this office it does not appear that any warrant has issued to John Hutchson for his services in the late revolutionary war with Great Britain.
