[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I do hereby certify that John Philips enlisted in my Company of riflemen the 10th day of March 1777 for three years – the 4th of July following he died in service. Given under my hand this 26 day of November 1783.



From the books in this Office the following warrants appeared to have issued in the name and for services rendered by John Philips in the Continental line viz.

1 for 200 acres issued to John Philips the 24th June 1783 for services during the War in a company commanded by Captain Beattie's station at Fort Pitt.

1 for 100 acres issued the 31st of December 1784 to William Philips as heir at law of John Philips, 3 years service.

1 4 100 acres issued the 10th December 1785 to John Philips for 3 years service.

This day John Phillips made oath before me, a Justice of the peace for the aforesaid County, that he is the same John Phillips alluded to in the certificate of Colonel Samuel J Cabell dated the 25th day of the present month, and that he has not received his Land Bounty – nor has he assigned his claim for the same to any other person. Given under my hand this 26 day of November 1811


