## Petition of Henry Ailshite VAS1828 Transcribed by Will Graves

Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all Men by these Presents that I Henry Aishite of Shenandoah County and State of Virginia for Divers Reasons and good Causes me hereunto moving do hereby Assign over unto Joseph Strother of Culpepper County and State aforesaid my Right and Title to a Certificate for Twelve Months Service in the Continental Army he having my Discharge given from under W. Croghan Major Commandant. I enlisted under Jonathan Clarke of Shenandoah County in the Eighth Virginia Regiment & served about Nine Months under him he then being appointed a Major I was put under C<sup>o</sup>\_\_ Ballard in the Fourth Regiment & served out my Time under Lieut. James Curry & at the end of my time was Discharged by W. Croghan Major Commandant & do by these presents Desire the Auditors of Public Accounts or any Other Person or Persons that may have the Right & Authority to grant a Certificate on said Discharge unto Joseph Strother or his Order. Given under my hand this 4<sup>th</sup> Day of February 1791

To the Hon. the Speaker of the House of Delegates the Petition of Henry Ailshite of the County of Shenandoah Humbly Sheweth,

That he served from February 1778 until February 1779 being the Term of his Enlistment in the fourth Virginia Regiment for which service he has not received his pay from the State he therefore Prays the General Assembly that they Allow him his Pay and pass an Act Directing the Auditor of Public Accounts to settle the same and your Petitioner as in Duty bound shall ever pray &c
