[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Jeremiah Pickett was a Soldier in the Continental Army during the revolutionary War and resided, at the time of his enlistment, near the Subscriber in the County of Caroline and State of Virginia. After the termination of the War the said Jeremiah Pickett intermarried and after having an only child, removed himself to distant parts and has not been heard of for twenty years as the subscriber knows of and that his only child hath departed this life. That William Pickett now living in the said County of Caroline is the only Brother of the said Jeremiah now alive to the knowledge of the Subscriber. Certified the 30<sup>th</sup> day of August 1812

I do certify that Jeremiah Pickett was a Soldier in the Continental Army, and that William Pickett above named, now living in my neighborhood, is the elder brother of the said Jeremiah & consequently heir at law to the deceased child of the said Jeremiah. Given under my hand this 8<sup>th</sup> day of October 1812.

William Toomes<sup>1</sup> this day came before me & made oath that Josiah Pickett was in the service of the United States until Colonel Bluford's Defeat [Buford's defeat, May 29, 1780]. Given under my hand this 26 of May 1813
