Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## [From Digital Library of Virginia ] Loudon County legislative petitions

Virginia. -

To the Honorable the Speaker and other Members of the House of Delegates of

The Petition of Alexander McMaken of the County of Loudoun humbly sheweth – that your Petitioner was appointed a Captain of a Company of Militia in the County of Loudoun during the late War between the United States of America and Great Britain and took upon himself the Command thereof, that during that Period a law was passed by the General Assembly of Virginia at their Session in the year 1779 that each Company of Militia should furnish two soldiers by enlistment each individual paying a certain sum of money for the bounty of such Soldiers which they were to be Credited with in their next year's Taxes – Your Petitioner further sheweth to your Honorable House that the Individuals in his Company as well as those in a Company at that time commanded by a certain Captain Thomas Respess appeared dissatisfied with the Law and did not step forward to aid their Country by advancing the respective sums demanded of them apprehensive that their money would never be reimbursed them nor Credit given in their next year's Taxes, and your Petitioner being Zealous to promote the good of his Country at that Crisis of Affairs advanced nine hundred pounds the bounty of four soldiers, two for his own company and two for the Company of Capt. Respess well hoping that the Commonwealth would either reimburse his money or give Credit to each individual in their next year's Taxes, at which time your Petitioner begs leave to show to your Honorable house that his money was never reimbursed him nor Credit given in the next year's Taxes agreeable to the then existing Law except Ninety Dollars, as will appear by the Deposition and documents sent herewith – the Sum your Petitioner advanced was £900 – as before stated leaving a balance due your Petitioner of £873 – all of which allegations your Petitioner can prove by indisputable Testimony.

Your Petitioner Humbly solicits your Hon. House to grant him relief in the premises and your Petitioner as in Duty bound will ever pray.

The deposition of Thomas Respess who deposeth and saith that the Two Soldiers enlisted by Alexander McMaken and exempted Two [indecipherably faint word] in this Respess's Company of militia, and the money for their bounty was to be paid by the Classes in proportion to their assessment and they were to have Credit for their Taxes but there being [one or more indecipherable words] between the said McMaken and said Respess about the collection it was neglected except Ninety Dollars which said McMaken received though not collected till the fall 1780 which sum is all that ever the said McMaken or myself received from the aforesaid Classes to the best of my knowledge.

The above deposition was sworn to before me the subscriber this 15<sup>th</sup> March [? 1796 Given under my hand


