
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

At a Court held for Madison County the 24th day of October 1811

Ordered that it be certified to the Executive of this state that General James Williams and General Edward Stevens¹ certified to this Court that sometime in the fall of 1776 or beginning of 1777 Samuel Yowell late of Madison County was enlisted by Captain John Gillison² for the term of three years, and that in March 1777 he marched with said Gillison's Company to New Castle on Delaware [River], and sometime after joined the 10th Virginia Regiment commanded by the

said General Edward Stevens who was then Colonel at Boundbrook [?]³ in Jersey; they also recollect perfectly well his serving the Campaign of 1777 or the winter of 1778; and that they had have no reason to doubt his having served the Campaign through, and believe he was Sergeant in said Captain Gillison's Company. They also Certified that Thomas Yowell a Brother of said Samuel was enlisted in said Company for three years and died in the hospital at Middlebrook in the year 1777
