I William Cannon Certify that Frederick Barnes a Soldier of the revolutionary war, was a private in Capt Tabbs company served about five years and was honorably discharged. I further certify that part of the time he acted as a Soldier of the Cavalry under Capt Armistead [probably William Armistead R12155], that while with Capt Armistead, he met the enemy, and was wounded very severely, but recovered to the surprise of all who saw him. Given under my hand this 3rd July 1832.



Princess Ann [sic: Princess Anne] County to wit:

I Jon'a Hunter hereby certify that William Cannon this day made oath to the above certificate before me
Given under my hand and seal this 3rd July 1832 Jon'a Hunter J.P.

I Thomas Bonney [S6688] certify that I knew Frederick Barnes a Soldier of the revolution, I remember he was severely wounded, but lived till after peace. Given under my hand this 9th July 1832.

I William Douge upwards of seventy years old certify that I knew Frederic Barnes. I always understood that he was a soldier in the revolutionary war and I remember seeing the scar of a wound which he received in the service. Given under my hand this 10th July 1782.

I Francis Ayres aged 74 years certify that I knew Frederick Barnes a soldier of the revolutionary war he was an enlisted soldier and received a severe wound while in service which he told me was done by the British light horse. Given under my hand this 11th July 1832 Fran hisXmark Ayres

I, John J. Burroughs clerk of the County Court of Princess Anne, aforesaid, do hereby certify that Jonathan Hunter, before whom the annexed and foregoing certificates of Thomas Bonney and Francis Ayres to the service of Edward Bonney [VAS2385], and William Cannon and Thomas Bonney to the service of Anthony Barnes [VAS2382], and Thomas Bonney, Malachi Carroll [S8180], William Douge and Francis Ayres to the service of Nathan Douge [VAS2386], and Thomas Bonney, William Douge & Francis Ayres to the service of Thomas McClennen [VAS2387], and William Cannon, Thomas Bonney and Malachi Carroll to the service of John Brown [VAS2388], and William Cannon and Thomas Bonney to the service of Solomon Malbone [VAS478], and William Cannon, Thomas Bonney and Francis Ayres to the service of William Turner [VAS2389], and William Cannon, William Douge and Francis Ayres to the service of Jonathan Dawley [VAS2390], and William Cannon, Thomas Bonney, William Douge and Francis Ayres to the service of Frederic Barnes, were severally made and sworn to, is a Justice of the peace of the said County of Princess Anne, duly Commissioned and qualified according to law, and that full faith and credit is due to all his acts as such. and I do further Certify that the signature "Jona Hunter J.P." to the said several Certificates of the affidavits aforesaid is in the proper hand writing of the said Jonathan Hunter.
