

State of Kentucky Bourbon County

I Certify that I was well acquainted with John Clark A Souldier who served in Colo Harrison [Charles Harrison VAS1411] Regt of Artry in the Virginia Continental line from the spring of 1779 to the close of the war. And It is my impression that said Clark served as a Non Commissioned Officer I was a Lieut in the same Service.

State of Ohio Pickaway County SS

On the 12<sup>th</sup> day of November 1821 John Clark of the County & State aforesaid Being of sound mind and memory And a person of credibility personally appeared before me the underneath subscriber a Justice of the peace for the County aforesaid and made oath according to law and saith that in the spring of the year 1779 that he the said John Clark Enlisted in a Regiment of Artillery [several undeciphered words] which Regiment belonged to the Virginia continental line and was commanded by Colonel Charles Harrison of [one or two undeciphered words]. And further that he the Deponent was appointed a sergeant in said Regt in which [undeciphered word] he continued to serve to the end of the War [several undeciphered words] that he obtained a discharge [several undeciphered words] which discharge he has since by accident lost. And further that he has never obtained the warrant for [several undeciphered words] State of Virginia for the aforesaid service and that he has never [two undeciphered words] or assigned his claim thereto unto any other person and now prays that the honorable Executive & Council of the State of Virgira may allow unto him the said John Clark the bounty in Lands for said services as a Sergeant and for the purpose of obtaining a warrant for the same he the said John Clark appoints John Evans his agent or Attorney to apply for and receive the same. And further this Depont saith not



I hereby Certify that I was acquainted with John Clark who belonged to the 1<sup>st</sup> Virginia Continental Reg't of Artillery I knew him in the Spring of the year 1778 a private souldier in said Redgt he was promoted first to a Corporal & second to a Seargent in said Regt and he was in Service when Genl Greens Army was encamped at Ashly Hill South Carrolina in 1781 [sic: Gen. Nathanael Greene at Ashley Hill, 7 Jul - 14 Dec 1782] as well as I now recolect when I left the Army to [undeciphered word] But have reason to beleive he continued in Service to the end of the war I served as a Lieut in said Regt.
