[The following are from [rejected claims in the Library of Virginia](#). The file also contains a power of attorney signed in March 1840 by Mary Allington as heir of George Clour. There are other documents in the file that add nothing to the record.]

Virginia. Shenandoah County to wit: [8 July 1839]

The Deposition of Abraham Rinker, who testifies that he is a son and the administrator of Jacob Rinker Deceased who served as first Lieut. in Capt Jonathan Clarke's [sic: Jonathan Clark VAS2169] Company in the year 1776 and that he found among the [undeciphered word] papers a list of the men belonging to said company & among others, the name of George Clour [undeciphered word] thereon. The deponent further states that he was well acquainted with said George Clour and his family, and that after his death he left the following children viz: John Clour, George Clour, Joseph Clour, Samuel Clour, Henry Clour, Mary Allenton, Elizabeth Kishour, (since deceased, having heirs) A. Rinker

Know all men by these presents that we John Clour George Clour, Joseph H. Clour, Samuel Clour, Henry Clour, Philip Miller Susan Miller & Peter Kershour guardian for Peter Kershour Jr and David Kershour infants under Twenty one years of age and heirs at law of Elizabeth Kershour formerly Elizabeth Clour; Heirs at law of George Clour dec'd do hereby authorize and empower Wilford G. Settle [rest of power of attorney not transcribed] [10 March 1840] John Clouier/ George hisXmark Clower Joseph H Clauer/ Samuel Clower/ Henry hisXmark Clower/ Philip Miller/ Susan Miller Peter Koushouer Guardian of Peter Kershouer/ David Kershour

Virginia to Wit [18 April 1840]

At a Court held for the County of Shenandoah on Monday the 13<sup>th</sup> day of April 1840 the following order was entered upon the minutes of said Court.

It is ordered to be certified that it appears to the Court by satisfactory evidence adduced in open Court that George Clour who as a private in the Virginia Line in the revolutionary war and died since the year 1787, to wit on the 15<sup>th</sup> day of May 1822. That the said George Clour died intestate and leaving [undeciphered word] his widow (who has since died on the 19<sup>th</sup> day of July 1835[?]) and the following named heirs to wit John Clour George Clour Joseph H Clour Samuel Clour and Henry Clour his sons, and Mary Allenton and Elizabeth Kershour his daughters, who were all and the only heirs at law of the said George Clour at the time of his death, that Elizabeth Kershour hath since died intestate leaving Susan Kershour Peter Kershour and David Kershour her children and only heirs at law That Susan Kershour has since intermarried with Philip Miller And that the said John Clour George Clour Joseph H Clour Samuel Clour Henry Clour Mary Allenton Susan Miller Peter Kershour Jr & David Kershour are now all and the only heirs at law of the said George Clour dec'd.
