Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

Of the affidavit of Holladay Revel<sup>1</sup> of the County of Southampton in the State of Virginia taken this 16<sup>th</sup> day of November 1833 at Jerusalem in said County. This affiant being duly sworn saith that in the latter part of the year 1777 he was marched as a soldier in the Continental Army of the Revolutionary War from the aforesaid County to Valley Forge in Pennsylvania and there met with Henry Oberry who was also a soldier and whom this affiant was acquainted with before he left home, that when this affiant who served 3 years in said Army was discharged he left the said Henry Oberry as a soldier at the aforesaid Valley Forge and further saith not
