Pension application of Tscharner (Ischamer) DeGraffenreidt (Degraffenredd) VAS389 <u>vsl 20VA</u>

[Methodology used by Will Graves (not Leon): Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Addendum to Tscharner (Ischamer) DeGraffenreidt (Degraffenredd) VAS389 By C. Leon Harris. 7 March 2014.

...Colo. Abraham Buford do hereby certify that Tscharner deGraffenreidt of Lunenburg Co'y Virginia acted as a Sergeant in a Company of the Continental line which was with those commanded by Colo Abr'm Buford that at the Battle or engagement between the troops under Colo. Buford & the troops under Colo Tarlton near the hanging Rock at the Waxsaw Settlement in South Carolina in May 1780 the said Tscharner deGraffenreidt then a Sergeant in the said American troops was in the said Engagement commonly called Buford's defeat from the first to last — that the said deGraffenreidt was badly & dangerously wounded but cannot recolect at this time the particular wounds he rec'd. only his head & hands being Cut most shockingly & a Bayonet wound in his Side — & that upon the whole (he having seen the said deGraffenreidt since) he was disabled ever after from obtaining a livelyhood by any kind of manual Labour. Certified by me this 16th October[?] 1786....

[*] Excellency Their Honours the Governour & Council of Virginia

The humble petition of Tscharner de Graffenreidt Jr of the County [*]enburg sheweth that your Petitioner was a Sergeant in the [*]ent upon Continental establishment & as such acted in the [*] commonly called Beaufords defeat. that your Pet'r [*] most dangerously wounded in seventeen parts of his [*] with Sword Ball & Bayonet & is rendered incapable of [*]ing a livelihood by his manuel labour for the [*] & evidence of which your Pet'r begs leave humbly [*] for your Excellency & Honours to the Certificate [*] Lunenburg County Court. Your Pet'r therefore craves [*] your Honourable Board will place him upon the [*] Pensioners as a person Lawfully entitled thereto & that [*] Pet'r. may receive the same accordingly.

At the Court held for Lunenburg County the 19th day of February 1787

It appears to the Court by evidence and the personal knowledge of some of the present Members that Tscharner DeGraffenreidt Junior was wounded and maimed in the battle commonly called Beaufords defeat [Buford's Defeat or the Battle of the Waxhaws, May 29, 1780], where he was acting as a Serjeant in the Virginia line upon Continental establishment and has not yet been placed on the list of Pensioners:

It is ordered that he be represented to the Honorable the Executive as a Person justly & lawfully entitled to be placed upon the said List, & received his Pension of accordingly.

It also appears to this Court that from the circumstances of the said DeGraffenreidt he is unable to in person to attend the Executive.

I hereby certify that I have viewed the wounds of Tscharner deGraffenreidt Jr. of the County of Lunenburg said to be received in the battle between the Troops of America & Britain in the Waxsaw settlement between Colo Buford & Colo Tarlton [Banastre Tarleton] (& commonly called Bufords defeat) & it is my opinion that the said wounds rendered the said DeGaffenreidt incapable of obtaining his livelihood by manual labor – given under my hand a Practitioner of Physic residing at Lunenburg Court house the 22nd day of December 1787 Attest Teste: Jolson, JP

I do, with the advice of the Council, hereby Certify that Tscharner Devraffenreidt, aged about Thirty four, Late a Serjeant in a detachment of the Virginia line commanded by Colo. Abram Buford and whose pay was at the rate of Thirty Six Pounds per annum was disabled in the Service of the United States by several dangerous wounds received in his body, head and arms; And that he is allowed the sum of Eighteen Pounds yearly to commence from the first day of January, 1786.



This may Certify that Tscharner DeGraffenreidt was a Serjeant in a detachment under the command of Colo. Abram Buford at the time Colo. Buford was defeated at the Waxhaws in

South Carolina by Lieutenant Colo. Bannister Tarleton on the 29th day of May 1780 – that the said Tscharner DeGraffenreidt was then and there very badly wounded by being nearly deprived of the use of both his hands together with several other wounds apparently mortal – I do further certify that the said Tscharner behaved with distinguished gallantry: He belonged to the Virginia troops in the Continental service, but to what particular Regiment I do not describe as I had myself only been a few days with that Corps and had never seen the same mustered.

Given under my hand at Lunenburg this 21st day of June 1787.
