Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Petition for Bounty land

Alexander Maddox – Soldier S. L.

This soldier's name is on the Army Register. He received £43.1 the balance of his full pay as a soldier – State Line (see auditor's certificate)

Patrick McEwen, a credible witness, says that Alexander Maddox was a Soldier in Captain Thomas Ewell Company, in the first Virginia Regiment commanded by Colonel Gibson, for three years, and was killed in the Army. The said Maddox enlisted with the witness in 1776 for 3 years, and served until he was killed.

Hugh Davis & George Mills, both credible witnesses, state that Maddox enlisted in 1776, in Captain Thomas Ewell's Company for 3 years and was killed in the service.

On this day of February 1834 appeared in person before the subscriber a Justice of the peace for said County Patrick McEwen<sup>1</sup> a soldier of the Revolution aged 81 years who being first duly sworn according to law on the Holy Evangelists declares that Alexander Maddux [sic] was a soldier in Captain Thomas Ewell's company Virginia State line George Gibson Colonel 1<sup>st</sup> Regiment – for three years and was killed in the Army – said Maddux enlisted in 1776 in said company with said McEwen for three years and served with him but he was killed.

On this 15<sup>th</sup> day of February 1834 Hugh Davis<sup>2</sup> a soldier of the Revolutionary War aged 79 years appeared in person before me James Foster a Justice of the peace for said County, and being first duly sworn according to law states that he well knew Alexander Maddux and that he

Flugh Bars

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 28<sup>th</sup> day of July 1776, in the name of Alexander and, as a Soldier for £43.1.0, which Certificate appears to have been delivered to Mr. Keith and was given for services prior to the 1<sup>st</sup> January 1782.

Given under my hand, at the Auditor's Office, Richmond, this 29<sup>th</sup> day of March 1834.

On this 15<sup>th</sup> day of February 1834 George Mills a soldier of the Revolution, aged 77 years, appeared in person before me James Foster a Justice of the peace for said County, and being first duly sworn according to law declares that to his knowledge and recollection Alexander Maddox enlisted in the year 1776 in Captain Thomas Ewell's Company for 3 years in the Virginia State line that said Company was attached to a Regiment commanded by Colonel George Gibson (first Virginia Regiment) that said Alexander Maddox was killed whilst in the Army.
