

Daniel Thomas a soldier of the Virginia State Troops, is entitled to the proportion of land allowed a soldier for serving during the war

Given under my hand/ 22^d April 1783
Ab Crump Capt [Abner Crump R13459]
V Troops



The deposition of John Butler [S8115] of King William County and State of Virginia who is seventy one years of age on the 19th last month (January) taken before me this 11th day of February 1834, he being first duly sworn, this deponent deposeth and saith that he was well acquainted with Daniel Thomas who was also born and raised in the aforesaid County & State, that the said Daniel Thomas was a soldier of the revolution, that he enlisted during the war and was at the siege of York [28 Sep - 19 Oct 1781], this deponent saith that he thinks Daniel Thomas was discharged at the City of Richmond in Virginia, that he saw Daniel Thomas once during the war he having obtained a furlow to visit his friends in King William and during his visit he married the Widow Edwards, and further this deponent saith not.



The deposition of James Terry [S17141], who is eighty four years old the 14th day of this month, and was born and raised in King William County and State of Virginia. This deponent deposeth and saith that he was well acquainted with Daniel Thomas who was born and raised in the said County and State, and that the said Daniel Thomas enlisted in the United States service as a private soldier for three or five years, this deponent does not recollect which, that he enlisted under Capt William Mosby [VAS767] in Henrico County in the year 1775, was marched to the north and there was discharged, and again enlisted for and during the war and returned during the war having obtained a furlow for that purpose, and married the widow Edwards, and after the war of the revolution he returned and settled in the aforesaid county & lived many years in it, and further this deponent saith not

The affidavit of David Edwards of the County of Hanover and State of Virginia who is sixty six years old this day taken before me the 14th day of February 1834 he be first duly sworn, this deponent saith that he was well acquainted with Daniel Thomas that he lived in the County of King William in the aforesaid state That he was a soldier of the revolution; that he married his mother Lucy Edwards, and a short time after they were married they found out that he had inlisted in the sevice of the United States, he remain'd with her about two months, he then left home and joined the army again and continued in the services untill the war was ended – and further he saith not

The affidavit of Nancy Toombs who is about seventy years old and was born in the county of King William and State of Virginia, Saith that she was well acquainted with Daniel Thomas That he lived in the County of King William State of Virginia that he was a soldier of the revolution, that he married her mother Lucy Edwards, a short time after they were married he told them that he belonged to the army that he had enlisted in the services of the United States, he remained with her about two months and joined the

army again and continued in the service until the war was ended which lasted several years after they were married during that time he obtained a furlow and visited his family a short time and then returned to the army – and further this deponent saith not. [signed] Nancy Toombs

The affidavit of Anslem Bailey [Ansolem Bailey S37702] of the County of Henrico and State of Virginia taken this 15th day of Feby 1834

This deponent declares that he is upwards of seventy five years of age at this time that he resides in the County of Henrico. That he became acquainted with Daniel Thomas in the year 1776 that at that time said Dan'l Thomas was a soldier in the 1st Regiment in the Continental Line commanded by Col. George Gibson [BLWt1985-500], that he enlisted for 3 years which he served & after being discharged entered the army for the whole war. that he served throughout the war & was honorably discharged after which he went into the County of King William since which he has never seen him.
