

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of New Jersey County of Gloucester: SS

John Mapes (or Maypes) aged eighty years do hereby solemnly affirm testify and declare that in the year 1778, I enlisted for the term of "during the War" and served in the Regiment No. ___ under the command of Colonel Lee [Henry "Light Horse Harry" Lee] of the Virginia Line, and that I continued in the service aforesaid until the close of the war, when I was regularly discharged from the said Regiment commanded by Colonel Lee. – I further declare that I have never received a warrant for the Bounty Land promised to me on the part of the ~~United~~ State of Virginia nor have I ever assigned or transferred my claim in any manner whatsoever. Therefore – [boilerplate power of attorney whereby the veteran appointed Colonel Joseph Wilson of Washington City as his attorney to pursue his claim against Virginia.]



State of New Jersey Gloucester County: SS

On this the 15th day of July A.D. 1830 before me the Subscriber one of the Justices of the Peace in and for the County of Gloucester – Personally came James B Cooper¹ who being duly affirmed according to law: upon his solemn affirmation saith that he is a Commissioned Officer in the Navy of the United States, and served in Lee's Legion of the Virginia line during the Revolutionary War. And was personally acquainted with John Mapes a Soldier in the first troop of said Legion, who served until the Piece of 1783 and was regularly discharged in the State of South Carolina at the close of the war – And this affirmant further states that after the War. In [sic] this affirmant finding that a number of persons were of the name of James Cooper, he this affirmant assumed the letter B in the middle of his name for a distinction and that he has ever since been known, called & distinguished by the name of James B Cooper.
