[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

...he was on board the Ship *Tartar* as a Midshipman, and that ... heaving up the Anchor, John Marshall who was ...wains mate [boatswain's mate] on board said Vessel was heaving ... the half deck, the said Thomas Grant saw Marshall Jamb'd [jammed?] by a Capson [capstan] bar and rec'd a hurt at that time in his Breast or side which rendered him incapable of doing duty for Some considerable time. The said Grant has since seen the said Marshall, and, by the said Wound, which has increased, upon him, he appeared to be incapable of maintaining his family – King George County

I do hereby Certify that the within named John Marshall has lived on my land for several years, & has during that time, taken every step to support his Family, & I believe him to be unable to Labor on Account of the Wound he got, in the Service, as I have heard the Opinion of several Doctors, in Respect to his Complaint.

King & Queen [County Virginia] November Court 1786

John Marshall Boatswain's Mate on board the Ship *Tarter* having received a wound and from the report of Benjamin Walker Surgeon and several certificates produced by the said John Marshall – the Court are of opinion that he the said John Marshall is incapable of military duty or of obtaining a livelihood by labor and all to be put on the pension list with an allowance of 10 pounds annually.



I do, with the advice of the Council, hereby certify, that John Marshall, about ___ years of age, late a Boatswain's Mate in the ship *Tartar* appears to have been disabled in such a manner while in the Service of the State of Virginia as to entitle him to the sum of eight pounds yearly which allowance is accordingly made him, to commence from the first day of January 1786.

Given under my hand, as Governor of the Commonwealth of Virginia, at Richmond, this 19th day of December 1786.



I Elkanah Andrews¹ aged 68 years do hereby declare and make known that I was a sailor on board the armed vessel called the *Accomack* belonging to the Virginia State Navy during the war of the revolution, commanded by Captain William Underhill, and I do further certify that John Marshall was Boatswain's Mate on board the said vessel and that he served as such without intermission and successively, from the time she was launched until she was laid up which was more than 3 years – given under my hand this 3rd of November 1832
