

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

I do Certify that Matthew Johnson, John Papp [?], Philip McDade and George Young Enlisted as soldiers in the Legionary Corps commanded by Colonel Armand [Charles Armand Tuffin, Marquis de la Rouerie] of the Late Continental Army while the said Corps was stationed at Winchester, the said Matthew Johnson for during the war, and John Popp [?], Philip McDade and George Young for the term of three years – that they each of them Served in the said Legionary Corps until the dissolution of the Continental Army – that they were Honorably discharged at York Town Pennsylvania sometime in the month of November 1783 – and that they each of them were Citizens of the State of Virginia at the time of their Entering into the Service of America. Given under my hand this 7<sup>th</sup> day of February 1799

I do hereby Certify that Clement Green and Basil Carlile was Soldiers in the first Partizan Legion in the Continental Army commanded by Colonel Armand, and was legally discharged therefrom the 15<sup>th</sup> day of November [paper compromised and illegible text] in witness whereof I have hereunto set my hand this 5<sup>th</sup> day of December 1798
