Bounty Land Warrant information relating to Salathel [Salathiel] Milby VAS661 [vsl 4VA](#)

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I certify that Robert Russell Senior¹ a Revolutionary pensioner & a man of truth & veracity came before me & made oath that Salathel Milby of this County enlisted in the 9th Virginia Regiment for 3 years & was captured & in prison and with the witness at Germantown [October 4, 1777] & was in service & imprisonment nearly or quite four years. Witness my hand & seal as a justice of the peace in & for the said County (Accomack) this 21st day of January 1834

I certify that Levin Hyslop² who is a Revolutionary pensioner & a man of truth & veracity came before me & made oath that Salathel Milby of this County enlisted in the 9th Virginia Regiment for 3 years & was captured at Germantown – & was in service and imprisonment nearly or quite four years. Given under my hand & seal as a justice of the peace in & for Accomack County this 21st day of January 1834

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 17th day of November 1785, in the name of Salathiel Milby, as a Soldier of Infantry for £11.14.3, which Certificate appears to have been delivered to Col. Cropper and was given for services prior to the 1st January 1782.
