Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

This is to certify that Michael Moore, a private Dragoon in the First Partisan Legion under my Command, has served faithfully & bravely to this Day, is hereby discharged from the service of the United States, in Pursuance of Orders received from the Commander in Chief, bearing Date the third instant.

I further certify that Michael Moore a private Dragoon having been enlisted in the State of Virginia is intitled [entitled] by the Resolution of Congress, of the 13th February, 1779, to the Benefits that have been, or hereafter shall be, granted by the said State to the Noncommissioned Officers and Soldiers of the said Line.
