[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Illinois Monroe County

I David Nowlin Clerk of the Circuit Court of said County, do certify that it is proven in Open Court to the satisfaction of said Court – that the within named Louis Leconte, Lewis Lamarch, John B Lamarch and Beauvard Lamarch were soldiers in the revolution, in the Illinois Regiment commanded by Colonel George Rogers Clark. That they served between 3 and 4 years, when the Regiment was discharged, and that never received a warrant or warrants for the bounty land promised them, either on the part of the United States, or the State of Virginia – nor did they ever transferred their claims to it or therein in any manner whatsoever. It is further proven that the said Louis Leconte, Lewis Lamarch, John B. Lamarch and Beavard [sic] Lamarch died intestate, and that the subscriber to the within instrument is the only heir.

In testimony whereof I have on to subscribed my name and affixed my official seal at Waterloo this 12th day of September 1834

[power of attorney executed September 10, 1834 by Josephtr [?] Leconte in which she claims to be the sole heir of her husband Louis Leconte, and only Heir of her brothers Lewis, John B. and Beauvard Lamarch. She signed a power of attorney with her mark.
