[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]





This is to Certify, That it appears from a List in this Office of such Officers and Soldiers

of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 2nd day of October 1784, in the name of George Rust, as a Soldier of Infantry for £14.15.8, which Certificate appears to have been delivered to Matt. Rust and was given for services prior to the 1st January 1782.

7th day of February 1834 .

Petition for bounty land –

Vincent Rush & George Rush: Soldiers C. L. [Continental Line]

The soldiers names are on the wrong Register – Vincent Rust received £14.2 the balance of his full pay as a soldier of Infantry (certificate delivered to Matthew Rust) – George Rust received £14.15.8 the balance of his full pay for which also the certificate was delivered to Matthew Rust.

The witness proves that the soldiers enlisted for 3 years, and probably both died in service. The affidavit of this witness has been in our line, in an objectionable manner.

These claims, may be good; but I do not think they should be allowed, in the present state of the evidence.

The affidavit of Moses Self¹ aged seventy-two years Deposeth and saith that he very well knew that George Rust and Vincent Rust enlisted in the revolution war three years under Captain George Turberville of Westmoreland County Virginia – this deponent further saith that he knew that the said George and Vincent Rust served many years in the said Revolutionary war and the said deponent believes that the said George and Vincent Rust both died in the said war for neither of them came back and further this deponent sayeth not. Given under my hand this 2nd day of December 1833.
