The original table has three additional columns labeled "When Entered," "When Discharged," and "Days in Service." Data are entered in the columns only for Capt. Robert Barnett and are evidently the same for all the soldiers: "3<sup>rd</sup> Novemb'r 1782," "23<sup>rd</sup> Novemb'r 1782," and "20 Days." During the period covered by the payroll (3-23 Nov 1782) troops commanded by Brigadier General George Rogers Clark

destroyed the Shawnee towns of Piqua, Standing Stone, and New Chillicothe in present Ohio. This was the last battle of the Revolutionary War.

Note that what was Lincoln County VA is now in Kentucky.
