Bounty Land Warrant of Nathaniel (Nathan) Bradwell BLWt1211-200 fn5SC

State of Georgia County of Liberty: SS: I James Sharp Bradwell of said State and County cousin and one of the heirs at law of Nathan Bradwell late of the district of Colleton South Carolina deceased do upon oath testify and declare that to the best of my knowledge and belief the said Nathan Bradwell was a Lieutenant in the Army of the Revolutionary War in South Carolina line on Continental establishment and served as such to the close of the War.

Also I do further testify and declare that I have never received a warrant from the United States for the quantity of land due the said deceased from the United States nor do I believe that he ever received it or transferred his right to it in any manner during his lifetime.

Therefore, no all men by these Presents that I James S. Bradwell as aforesaid do hereby constitute and appoint Colonel Joseph Watson of Washington City my true and lawful attorney for me and in my name to demand and receive from the Secretary of War of the United States a warrant for the quantity of land due me in right of said deceased.

And my said attorney is hereby fully authorized and empowered to constitute or appoint one or more substitutes or attorneys under him for the special purposes therein expressed in the same to revoke at will.

State of Georgia County of Liberty: SS: Be it remembered that on this day, the fifth day of February A.D. 1827, there has been adduced to me satisfactory evidence to prove that Colonel James S. Bradwell who has made the foregoing declaration on oath and subscribed the power of attorney herewith connected, is a 2nd cousin, and one of the heirs of Nathan Bradwell late a Lieutenant in the Continental Army of the revolution, and that the heirs of the said Nathan Bradwell are two in number, to wit: the said James S. Bradwell and Thomas Bradwell, who are second cousins to each other, and first and second cousins to the said Nathan Bradwell deceased; and that the said Colonel James S. Bradwell resides in the County of Liberty in the State of Georgia and that the said Thomas Bradwell resides in the District of Georgetown in the State of South Carolina;

and that the above named persons are all the heirs of the said Nathan Bradwell known to be living.

In witness of all which, I have hereunto affixed my hand and seal official, in my capacity of a Clerk of the Court of Ordinary for said County, this fifth day of February in the year of our Lord 1827.
