Bounty Land Claim of Southy Bailey BLWt1253-100 VA
Transcribed and annotated by C. Leon Harris. Revised 28 Feb 2017.

The Secretary of War of the U. S. will please issue a military land warrant to Tho. M. Bayly and in his name if he so directs for what may be due to Southy Bailey a soldier in the American Army in the Revolutionary war with Great Britain and who enlisted for and served until the end of the War. As witness my hand & seal this 10th day of June year 1808. Southy hisXmark Bailey

Richmond June 10 1833

Dear Sir I enclose to you three certificates from the Register of the Land Office for the [undeciphered word] of the Executive Whether or not the Register [of the Land Office] is Authorized to issue to me the additional hundred acres of Land the advice of council on which the original warrant was issued to me shows that the soldiers in these cases served more than 7 years, and consequently were in service before Apr 1780 With great Respect/ Dr Sir/ your Ob serv't/ Thomas M Bayly
Wyndham Robertson esqr/ Lt Gov. of Virginia

Land office/ Richmond 10 June 1833

I certify that on the 17th Sept 1807 a military warrant No 5325 for 60 acres of Land issued from this Office to Thomas Bayly Ass[ign]ee of Southey Bayly [Southey Bailey VAS932] for the said Southey Bayly's service as a Private for 1 yr & 10 mo's over 6 years

I certify that on the 18th of Jan 1808 a military warrant No 5370 for 261 acres of Land issued from this office to Thomas Bayly ass'ee of John Warrington for the said Warrington's services for 7 years & 10 mos, to the end of the War.

And I certify that on the 16 June 1807 a military warrant No 5139 for 200 acres of Land issued from this office to the Repres[enta]tives of Wm Case [William Case BLWt1826-100] for the said Case's service during the war

NOTE: The present Southy Bailey is apparently listed in a size roll of noncommissioned officers and privates (<http://revwarapps.org/b81.pdf>) as follows:

Southy Bailey/ age 18/ height 5' 4"/ dark complexion/ born and residing in Chesterfield County/ enlisted at Winchester on 15 May 1781 for 18 months.

He appears in the same size roll as second time as follows:

Southy Bayly age 20/ height 5' 4½"/ brown hair/ black eyes/ dark complexion/ farmer/ born and residing in Accomack County where he enlisted as a substitute for the duration of the war in 1781. Sized 10 June 1782.
