

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Received of the Secretary of War US military land warrant No. 1431 for 100 acres, issued in favor of the heirs at law of James McIntire who was a soldier of the Horen's [?]¹ Regiment – dated at Chambless' Store, this 19th day of December 1828

Virginia to wit

At a Court held for Bedford County the 24th day of November 1828 Satisfactory evidence was adduced in court to prove that James McIntire is the son – and one of the heirs at law in fee to James McIntire Deceased late a Soldier in the Hazens [Moses Hazen's] Regiment on Continental Establishment.

I Gustavus A. Wingfield Deputy Clerk of the County Court of Bedford do certify that the above evidence is taken from the records in my office. In testimony whereof I have hereunto affixed my official seal. This 26 day of November 1828.

I James McIntire son & one of the heirs at law of James McIntire do upon oath testify & declare to the best of my knowledge & belief that James McIntire did Enlist in 1778 for the term of during the war & served in Hazens Regiment under the command of Colonel Hazen on Continental establishment – I further declare that I have never received a warrant for the Bounty land promised to the said James McIntire on the part of the United States nor do I believe that he ever received it or transferred in any manner whatsoever therefore know all men by these presents that I James McIntire do hereby constitute & appoint Leroy Jordan of Bedford County to be my true & lawful attorney for me & in my name to demand & receive from the Secretary of war of the United States a warrant for the Bounty land due to me as aforesaid & my said attorney
