Bounty Land Claim for Thomas Warman BLWt1789-300

VA

[In the following, the name of Francis Warman has been inserted and "my" changed to "our," "He" to "We," and so on, indicated here in italics.]

State of Kentucky } We John Maddox Dyson, Eldest son of Elizabeth Dyson, alias Warman,  
County of Union Set } and Francis Warman Dyson an heir at Law of the late Captain Thomas  
Warman do, upon oath, testify and declare, to the best of our knowledge,  
and belief that the said Thomas Warman did Engage as an Ensign, or Lieutenant in 1775 for the "term of  
during the war", and served in the Regiment No (not known) under the Command of (say) Colonel Henry  
Lee (not certain) of the Virginia Line [see endnote]; and that he continued in the Service aforesaid until the  
year (say 1782) or when the war was closed. We further declare that we have never received a warrant for  
the Bounty Land promised to said Captain Thomas Warman on the part of the United States; nor do We  
believe that he ever received it, or transferred his claim to it in any manner whatsoever; Therefore, know  
all men by these presents, that we John Maddox Dyson & Francis Dyson aforesaid do hereby constitute  
and appoint John Boyle of Henderson County, in the State of Kentucky aforesaid to be our true, and  
lawful Attorney for us, and in our names to demand, and receive from the Secretary of War of the Untied  
States a warrant for the quantity of land due to us, and aforesaid & also all arrears of pay due to him; and  
our said Attorney is hereby fully authorized, and empowered to constitute, and appoint one or more  
substitutes, or Attorneys under him for the special purposes above expressed.



I do certify that Capt Thomas Wawman of the Va. Cont. line served to the end of the war. I know it positively and any evidence to the contrary is delusive. I was intimately acquainted with him. Witness my hand this 30<sup>th</sup> Sept 1822.

Captain Thomas Wawman's Heirs claim to additional Bounty.

He has rec'd 4000 acres upon the certificate of Gen'l. Mughlenburg [sic: Peter Muhlenberg  
BLWt1495-850]

that he entered the service 17 July 1776 & became a supernumerary in Jan'y 1783.

It now appears he continued in service till the end of the war, which from 17 July 76 was 7 years 3½

months. Capt Wawman is dead – the [illegible] 15 months additional service.  
This claim appears to be well supported if any of the Council know Col Blackwells hand writing.

1<sup>st</sup> Lieut. in Col. Moses Rawlings's [VAS683] Continental Regiment Feb 1777  
Captain Lieut. 23 Sep 1777  
Captured at Germantown 4 Oct 1777; exchanged 8 Dec 1780  
In 3<sup>rd</sup> Virginia Continental Regiment in Jan 1781  
In Col. Thomas Gaskins's [BLWt867-450] Virginia Regiment on Oct 1781  
Served to end of war, Nov 1783  
Awarded land bounty of 4777 acres.
