Revolutionary Claims

Under the act, entitled "An act for the relief of certain surviving Officers and Soldiers of the Army of the Revolution," approved the 15th May 2828 [sic, 1828]

Treasury Department 31 December 1832

Sir:

Your claim, under the above mentioned act, having been examined, you are found to be entitled to the pay of a Captain of Infantry in the Continental line. The amount which may be due, accordingly, will be remitted to you by the Treasurer of the United States.

Your commissions on our return.

I Samuel Warren aged 71 years, do upon oath testify and declare, that I entered the Service of the United States on the 10th day of July in the year 1778 as a Lieutenant and on the 18th day of August 1779 was promoted to a Captaincy of the Regiment No. 5 (commanded by Colonel Isaac Huger) of the South Carolina Continental Line; was twice wounded and taken Prisoner at the Siege of Savannah (where from my wounds I lost my right leg) and during the time I was a Prisoner, was deranged in my rank by an Act of Congress -- Immediately after being exchanged, I was on or about the ___ day of June 1782 appointed by General Greene Deputy Commissary General of Prisoners for the Southern Army and served until Peace was declared, when I resigned. I further declare, that I have never received a Warrant for the Bounty Land promised to me on the part of the United States; nor have I ever assigned or transferred my Claim in any manner whatsoever; therefore Know All Men by these presents, that I Samuel Warren aforesaid do hereby constitute and appoint the Honorable Robert T. Hayne to be my true and lawful Attorney, for me and in my name to demand and receive from the Secretary of War of the United States, a Warrant for the Quantity of Land due to me as aforesaid: and my said Attorney is hereby fully authorized and empowered to constitute and appoint one or more Substitutes or Attorneys under him for the Special purposes above expressed.
