
Bounty Land Warrant information relating to Charles Yarbrough BLWt1923-200 f8VA
Transcribed by Will Graves 7/14/11 rev'd 7/22/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Know all men by these Presence that I Isaac Huger of the City of Charleston in the State aforesaid have constituted, nominated and appointed and by these presents do constitute nominate and appoint my true and trusted friend John Adair, in the State of Kentucky my true and lawful Attorney, for and in my name, stead and to my use, to sue, ask, demand, levy and receive all sum or sums of money, rents, debts, lands, bonds & notes owing, payable, belonging to or demanded from me in the State of Kentucky and I hereby empower and authorized and appoint my trusty friend John Adair above mentioned to locate and secure one thousand acres of land I bought of Charles Yarbrough, his military, or parts of right thereof as an officer in the Virginia Line in the Army of the United [States] Also two hundred acres of land from Charles Yarbrough as an officer in the Continental Army (late) of the United States of America. I likewise bought of said Yarbrough as appears by his Receipt, both of which I by these presents assigned over to my friend John Adair. Witness my hand & seal this 5th day of May 1797.

I John Adair Assignee of Isaac Huger, who was the Assignee of Charles Yarbrough
deceased, who was a Lieutenant in the Virginia line do upon oath testify and declare to the best
of my knowledge and belief that said Charles Yarbrough served as a Lieutenant in the Virginia
line, and that he continued in the service aforesaid until the close of the Revolutionary War.

I further declare that I have never received a Warrant for the bounty land promised to said
Charles Yarbrough on the part of the United States, nor do I believe that he or his assignee Isaac
Huger ever received it, or that he ever transferred his claim to said line to any other person than
the aforesaid Isaac Huger.
