Know all men by these presents that I Robert Brownfield of Sumter District & State of South Carolina Position, formerly a Mate in the general Hospital of the United States during the revolutionary war, have constituted appointed & ordained General Thomas Sumter of the District & State aforesaid & by these presents do constitute appoint & ordained him the said General Thomas Sumter Senator in Congress my lawful attorney; to obtain for me & in my name from the Land office of the United States a warrant of survey for Land to which I am entitled in virtue of my appointment as Mate aforesaid. And in all things appertaining to the procuring of said Warrant, to act & do as if I myself were personally present -- In witness whereof I have set my hand & affixed my seal this 17th day of November 1806 & 31st year of the Independence of the United States
