

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Know all men by these presents that I Robert Quillin of Patrick County and Commonwealth of Virginia but late a soldier in the first Virginia Regiment do hereby constitute Jonathan Unthank [?]¹ of the County of Surry and State of North Carolina my Lawful attorney to receive for his own use my extra bounty of land from the United States for my Services in the Revolutionary War with Great Britain and in my name to execute any [indecipherable word or abbreviation]² or other instrument of writing which may be necessary agreeable to the [indecipherable word]³ office. Witness my hand and seal this 20th day of August 1807

State of North Carolina Surry County 20th of August 1807: Personally came before us Jesse Franklin and Jacob McCraw two of the Acting Justices of the Peace for the County aforesaid Charles Ross⁴ and made oath in due form that he was personally acquainted with Robert Quillin late a Soldier in the first Virginia Regiment in the revolutionary war with Great Britain, that the said Quillin was [indecipherable word]⁵ Soldier and was made prisoner with himself at the fall of Charleston, but does not know how or in what manner he was disposed of afterwards. Sworn to and subscribed before us
