State of South Carolina Abbeville District: SS

On this the 20th day of June A.D. 1856 before me James McCaslon a Magistrate within and for the District and State aforesaid personally appeared Mary Weed now in her eighty seventh year of age a resident of said District and State who being duly sworn according to law declares that she is the widow of Andrew Weed deceased who was a soldier in the Revolutionary War and the Regiment of \_\_\_ commanded by Colonel Anderson and General Pickens of South Carolina Militia that her said husband served different tours in said War in said State the particulars of which she is now unable to state, but that he made application to said State for a pension for said services & obtained and drew a Pension of \$60 per annum till his death except his last draw which was on the 10th day of February A.D. 1830 [last digit unclear]. She further states that she was married to the said Andrew Weed in Abbeville District State of South Carolina sometime in the month of December A.D. 1786 by one Robert Macklin a minister of the Gospel and that her name before her said marriage was Mary Grey, that her said husband died in Abbeville District South Carolina on the 10th day of February A.D. 1850 and that she is still his widow & refers to proves here with annexed or presented. She makes this declaration for the purpose of obtaining the Bounty land to which she may be entitled under an act of March the 3rd 1855 and declares that she has not obtain any bounty land under this or any previous act of Congress nor made any other application therefore & request the Commissioner of pensions to forward returns of this to Solomon King Andersonville South Carolina

I do hereby certify unto all whom it may concern that the name of Andrew Whig of Abbeville was placed on the Pension Roll of this State for an annuity of \$60 (C. Resolutions of 1827 Page 79) That he continued to draw his annuity from 1828 2 1849 when the last payment was made to him through the Tax Collector of Abbeville the receipt for which he is in the following words

"Treasury Office Columbia  
May the 18th 1849

Received of R C Griffin Treasurer of the Upper Division \$60 on account of Annuity of Andrew Weed paid him as Tax Collector of Abbeville.
