Transcribed and annotated by C. Leon Harris


[There is no original document in the federal file, but a file jacket is inscribed as follows:
“B.L.Wt.866-500 – Col. Issued Sept. 20, 1800 to Moses Green, Ex[ecuto]r. No papers.”

In the House of Delegates/ Thursday the 10th of June 1784
Resolved that John Green be allowed half the pay of a [illegible word] for life to commence from the
time his whole pay [several illegible words] the first day of January one thousand seven hundred
[illegible word] three
June 11th 1784 A Copy John Beckley C.h.d.
Agreed to by the Senate
Extract from the Journal/ H. Brooke CS

[Parts missing from the text are inferred in brackets.]
Colo. John Green having applied for Examination as a Pensioner find that two Balls hav[e] [p]assed
through the Head of the right Shoulder & the Spine of the Scapula; that there [is] great loss in the
substance of the Bones; that an anchylosis of the Joint is formed in [s]uch manner as to prevent his being
able to put his coat on or off without assistance; the Colo. says the wound was received at a place called
Marrow Neck in the State of new yo[rk] in the year 1776 [sic: Mamaroneck NY, 21 Oct 1776] – the free
use of the right arm is so greatly curtailed, that I am of [o]pinion the Colo. could not obtain a full
subsistance by hard Labour only & that from his sufferings he merits an allowance from his country.

I DO, with the advice of Council, hereby certify that John Green Esq'r, of Culpeper late Colonel of the
Sixth Virg'a. Regiment appears to have been disabled in such a manner while in the service of The
United States as to entitle him to the sum of One Hundred Pounds yearly: which allowance is accordingly
made him, to commence from the first day of January.

Given under my hand at Richmond, this 29th day of November 1786.

At a Court held for Culpeper County the 17th day of April 1787

John Green, Gent came into Court and made oath that he is an inhabitant of Culpeper County,
and produced a Certificate to the Court allowing him a pension of One Hundred pounds, which is ordered
to be recorded, and it is ordered that the sheriff of this County pay the said One Hundred pounds
according to Law. A Copy/ Teste John Jameson Cl.C.C[?] Cont.[?]

I do Certify that Colo. John Green was appointed a Captain in the first Regiment raised in Virginia on Continental establishment in September 1775 and I am well satisfied he continued in service 'til the close of the War at which time he ranked as a Colonel.

Given under my hand this 4th day of March 1805

Rich'd Taylor [Richard Taylor, pension application S46514]
Late Lieut Colo. Continental Line

NOTE: The receipt for payment of the pension on 2 Nov 1791 was witnessed by Gabriel Green. The receipt dated 17 Nov 1792 was witnessed by Moses Green. The last document in the state pension file is a receipt signed by Moses Green on 25 April 1795.
