Pension application of Carlton Keeling Ga15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

June 2, 1818 ¹

The following persons who reside in the county of Russell wishing to become pensioners under the act of Congress of the 18th of March last, entitled "An Act to provide for certain persons engaged in the land and naval services of the United States", declared on oath as follows:

Carlton Keeling declared that he served as a private soldier in the Revolutionary War, for two year, that he enlisted with Shim Cook a Lieut. in the 2nd Regiment of the Georgia Line in the service of the United States, commanded by Colo. Machintosh [Lachlan McIntosh], that he was at the Sieges of Ninety Six [May 22-June 19, 1781] and Savannah [September 16-October 18, 1779], and was discharged in the State of South Carolina; and that he is in indigent circumstances.

It also appears to the satisfaction of the court that the aforesaid applicants are persons of good credit as witnesses, and that they served in the Revolutionary War against the common enemy; and it was also satisfactorily proven to the court that the said John Ferrall, Leonard Pigman, Carlton Keeling, John Sykes, Abraham Childers, James Berry, Charles Sexton and Jacob Hess according to the report of their neighbors previous to the passage of the said Act of Congress had served as soldiers in the Revolutionary War; All which is ordered to be certified to the Secretary of the Department of War.

July 6, 1819 ²

Carlton Keeling, who at a court held for this county the 2nd day of June 1818, made a declaration on oath for the purpose of obtaining the pension allowed by the Act of Congress of the 18th of March, 1818, personally appeared in court and further declared that he enlisted in the Georgia line in the 2nd Regiment of the Georgia Line as stated in his first declaration in the month of April 1776, and was discharged in the month of April 1778 or about that time; whereupon it appears to the satisfaction of the judge of this court that the said Carlton Keeling did serve in the Revolutionary War as a soldier, and that his declaration is true; which is ordered to be certified to the Secretary of the War Department.
