[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I Danniell MCFearson [Daniel McPherson or Daniel McFearson or Daniel McFerrin] of the County of Orange & State aforesaid nigh twenty years old about five feet ten inches High With fair hair brown Eyes [a] blacksmith to [sic, by] trade have Voluntarily enlisted Myself a Continental Soldier for the term of three years or During the War with Great Britain to Serve in one of the Continental Regiments of this State and Have Received of Captain William Lytle five hundred Dollars Bounty & I do swear on the Holy Evangelist of almighty God that I will be true & faithful to the United States and be obedient to the orders of all the officers put over me & in causes behave myself as a Good & faithful Soldier agreeable to the articles of war made for the Government of the Continental Army & I do further Swear that I am Healthy Sound & clear of any ulcers or sores on my legs or any other part of my body & that I am no Seaman or foreigner & that I was a Sitizen [citizen] of this State Before the 18th Day of May 1818.
