Pension application of William Tarlton Taylor R10414 Elizabeth f21VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]


State of Kentucky Wayne County: Sct.

On this 12th day of December 1843 personally appeared before the subscriber a Justice of the peace for the said County Mrs. Elizabeth Taylor aged eighty-one years who being first duly sworn according to law, doth on her oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 4th, 1836. That she is the widow of William T Taylor who was a Soldier of the revolution, he served under Colonel Morgan who commanded the Regiment to which he belonged, the General's name she thinks was Starks, he was at the siege of little York – he was in the service eighteen months as shown by his discharge which she has frequently seen but is not now to be seen having been left in Loudon [Loudoun] County Virginia where she resided previous to her removal to this County. She refers to the public records which will doubtless show many of the particulars of his service.

She further declares that she was married to the said William T Taylor on the 4th day of April 1778, that her husband the aforesaid William T Taylor died on the sixth day of February 1811; and that she has remained a widow ever since that period.

[f p 8: On September 25, 1855 in Fleming County Kentucky, Burtis Ringo, 82, gave testimony that he lived near neighbor to William T Taylor and his wife Elizabeth Taylor; that Elizabeth prior to her marriage was Elizabeth Hampton, the daughter of Jeremiah Hampton; that William and Elizabeth were married in Loudoun County Virginia in 1778, he thinks; he states that he was present at their marriage.
