Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I certify that I have examined the claim of Littleton S White, son and only heir at law of William S White, deceased, who was a Surgeon's Mate in the Virginia State Navy; and I find that in 1834, half pay was allowed in this case under the act of July 5 1832, entitled "an act to provide for liquidating and paying certain claims of the State of Virginia," from the 22nd of April 1783, in the said Littleton S White now claims half pay from the first of July 1781, when his father left the service. The claim in my opinion should be allowed. I therefore certify that under the above mentioned act half pay is due said Littleton at the rate of \$91.25 per annum from the 31st July 1781 to the 29th of April 1783; and that the amount is payable to Henry Nathup, attorney of Littleton S White, son and only heir of William S White deceased.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 26th day of April 1785, in the name of William White as Surgs Mate Navy for £101.2.2 which Certificate appears to have been delivered to Colonel Cropper and was given for services prior to the 1st January 1782.
