[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

Know all men by these presents that we Daniel Valentine, son of Polly Valentine, who was the sister of Daniel & Peter Valentine who were soldiers in the revolutionary war, between Great Britain & the United Colonies of America, and Sarah Valentine daughter of the said Polly Valentine, both of the State & County aforesaid – do hereby constitute & point James Turner of the County & State aforesaid, our true & lawful attorney, with full power and authority for, in and as our names, to ask, demand and receive from the Government of the United States such pensions as we may be entitled to, as the heirs of the said Peter & Daniel Valentine soldiers in the war of the revolution – under the several acts of Congress on the subject of revolutionary pensions – and to take such steps, and adopt such measures, as he may be deem just & proper, to establish our claim to the said pensions, hereby ratifying, and affirming whatever our said attorney may lawfully do on the premises.

Given under our hands & seals the 25<sup>th</sup> day of October 1834.

At a court held for the County of Halifax and State aforesaid at May Term 1835 Satisfactory evidence was produced in open court to prove that Daniel Valentine and his Sister Sarah are the only children and heirs of Daniel Valentine who was a Soldier in the War of the revolution under Captain Bradley [George Bradley a/k/a "Gee" Bradley] of the 18<sup>th</sup> Regiment and that said Mary was also Sister and heir of Peter Valentine who was a brother to said Daniel and the said Peter was also a soldier in said war. I William Hill Secretary of State in and for the State aforesaid, do certify that it appears from the musterrolls of the Continental line of this State in the revolutionary war, that Daniel Valentine a private in Captain Bradley's company of the 10<sup>th</sup> Regiment<sup>1</sup> enlisted on the 7<sup>th</sup> of June 1779, for the term of 18 months, that nothing more is said of him on said rolls. I further certify that it appears from the Warrant book, that a Military Warrant issued to the heirs of Daniel Valentine for his military services for 640 acres of land at a time when all such Warrants were issued on the certificates of field Officers.

I William Hill Secretary of State in and for the State aforesaid, do certify that it appears from the musterrolls of the Continental line of this State in the revolutionary war, at Peter Valentine a private in Lt. Colo.'s Company of the 10<sup>th</sup> Regiment enlisted on the 20<sup>th</sup> of July 1778 for the term of nine months, that nothing more is said of him on said rolls. I further certify, that it appears from the Warrant book, that a Warrant for the military services of Peter Valentine was issued to the heirs of Peter Valentine for 640 acres of land at a time when all such orders warrants were issued on the certificates of field Officers.

A poor man of Color of this County named Daniel Valentine who lives in this vicinity & has been known to me many years, brought me a letter a few days ago from S. M. Knight a pension agent of Washington, calling his attention to a suspended case of his for a revolutionary Pension with a blank Power of attorney & proposal of terms for its presentation. As Mr. Knight who is not known to me demands a fee in advance which Valentine is too poor to pay, I have concluded as a matter of charity to write to the department, and if the rules of the office will admit, ascertain something about it for him. If allowable I hope you will let me know the grounds on which it was rejected.

I learned from Valentine that his application was made many years ago – some fifteen or twenty – by one James R Turner of this County now dead a very worthy man, & that he has heard nothing of it since; until he received Mr. Knight's letter.
