State of Alabama Butler County: County Court

On this the 2nd Monday in August in the year 1832 personally appeared in open Court before the Judges of the County Court now sitting Noah Whiddon a resident of said County & State aged between seventy & eighty years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

He is between seventy and eighty Years of age he has no record of his age, but it is in a book in the hands of a relation in North Carolina. He was born in Nash County North Carolina. He lived there till after the war. Entered the service not long after the war commenced. He served a Tour of three months personally under Captain Coleman a Continental officer and Wat. Gibson Lieutenant, his General was Linton. He marched from Halifax to Tarboro and through different parts of the State in pursuit and in search of the Tories. He was in no particular fight. He also hired a substitute to serve a tour of eighteen months and a tour of nine months. He received regular discharges but all have been lost. He lived in Nash County several years, and moved into Darlington South Carolina where he lived twenty odd years & from there he moved to this County & State. He can prove his services by one Noah Whiddon [sic, Brinkley Gandy] who lived near him in the time.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the Agency of any State.

Sworn to and subscribed on the day and year aforesaid.

In open Court personally came Brinkley Gandy¹ and being duly sworn upon his oath says that he was acquainted with Noah Whiddon before and during the revolutionary war, He knows of his being in the service as he states -- that he was a faithful soldier & true Whig he believes him to be as old as he says.
