Pension Application of William Armistead R12155

February 22^d 1845

I certify that I have examined the claim of the administrator of William Armistead, deceased, who was a Captain of Cavalry in the State Troops of Virginia, and I find that under the act of July 5, 1832, entitled "an act to provide for liquidating and paying certain claims of the State of Virginia," half-pay was allowed from the third of September seventeen hundred and eighty three to the day of his death. The administrator now claims half pay from the eighth of February seventeen hundred and eighty three to the 3^d of September 1783. It is my opinion that the claim should be allowed. I therefore certify that there is due to the administrator half-pay at the rate of Three Hundred Dollars per annum for the period claimed, and that it is payable to Henry Northup, attorney of John Jones, administrator of William Armistead, deceased.

I certify that I have examined the claim of the administrator of William Armistead, deceased, who asks for half-pay, under the act of July 5, 1832, for the service of said Armistead as Paymaster of Nelson's [Major-Commandant John Nelson W5414] Corps of Cavalry, Virginia State line, and I find that half-pay as a Captain has already been allowed, and that half-pay as Paymaster is yet due. I therefore certify that the claim should be allowed at the rate of one hundred and eighty Dollars per annum, from the eighteenth of January seventeen hundred and eighty two, when Nelson's Corps was disbanded, to the twenty third of November eighteen hundred and twenty two, when the said Armistead died; and that the amount is payable to Joseph Segar, of Virginia, attorney of Samuel S. Howard, administrator of said Armistead, deceased.

The Board took under consideration the act of the last Session for regulating the Military and Naval arrangements of this State and are of opinion that the State regiment, Major Nelson's Corps of Cavalry, Captain Roger's company of dismounted dragoons and part of a company of Artillery under command of Captain Kean should be consolidated and made a legionary corps, under the command of Colo. Dabney as Lieutenant Colonel Commandant, and one Major, consisting of three companies of infantry, two troops of Cavalry and one Company of artillery, with their proper officers. That Colo. Dabney be desired to call a meeting of the officers of the

several corps above mentioned, in order to determine among themselves upon the principles of accommodation and mutual convenience, who of them should retire, and who continue, and if they cannot agree, that they shall then take place according to their seniority. That the six months men be considered as annexed to the three companies of infantry, and that proper officers be retained to command them while they continue in service.
