I certify that I have examined the claim of the administrator of the late William Foushee, who was a Surgeon in the Virginia State Troops, and I find that under the act of July 5, 1832 entitled "an act to provide for liquidating and paying certain claims of the state of Virginia" half pay was allowed from the 3<sup>rd</sup> of September 1783 to August 21 1824 when he died. Half pay is now claimed from April 22, 1783 when his service terminated, to the 3<sup>rd</sup> September 1783. It is my opinion that the claim should be allowed. I certify therefore that half pay at the rate of Three Hundred and Sixty Dollars per annum is still due, and is payable to Stafford H. Parker, attorney of William F. Ritchie, administrator of William Foushee.

Inclosed is a memorandum of the medicines wanted for Major Nelson's Corps of Cavalry. The chest is at Mr. Moody's. A box of medicine is wanted also for Col. Crockett's Regiment. The wagons wil start (by which it goes) tomorrow or rather next day. You will be so good as to mention the quantities of the medicines ec. You think ought to be purchased, that orders may be issued to the Comm<sup>t</sup> of stores for that purpose.



A Warrant to Dr. William Foushee pr £58.0.10½ for Medicines to 9<sup>th</sup> Regiment.

Extract from the Journal of the Committee of Safety. Jas E Heath Aud. [Auditor of Virginia]

Accomack County Virginia Sct [20 July 1833]

Samuel Waples [pension application W6427], aged seventy seven years, formerly a lieutenant of the 9<sup>th</sup> Virginia regiment in the revolutionary war, being first duly sworn, deposeth and saith; that he knows that a certain Doctor Foushee, who married in the county of Northampton but whose Sir-name [sic] he does not recollect, was during the year 1776 a surgeon of the 9<sup>th</sup> Virginia regiment afs'd; that he saw him several times at the court house of Accomack County, and believes he was frequently and most of his time in Northampton county where a part of the regiment was stationed; previous to the time of s'd. regiment's marching to the North about the last of the year 1776. But when said Foushee was Commissioned or how long he served this deponent knoweth not; but beleives that he marched with said regiment to the line of the Eastern shore of Maryland bordering on Virginia, but does not know whether he proceeded further North with the regiment or not. And further this deponent saith not.



The petition of William Foushee and others Heirs and devisees of Dr. William Foushee dec'd. respectfully represents to the Governor that the said Dr. W. Foushee entered the army of the Revolution as a surgeon to the 9<sup>th</sup> Regiment (Virginia) as will appear by the extract from the Journal of the Committee of safety and the accompanying affidavit of Lt. Waples an officer of said Regi't.

It also appears from the journals and other records of the revolution that D. Foushee was subsequently appointed Director of the Hospital at Richmond in which capacity he continued until the close of the war, as the extracts filed herewith shew conclusively.

The extracts of payments to Dr. [John Minson] Galt are exhibited merely to shew that Dr. Foushee rendered similar services – both having charge of Hospitals.

Your petitioners pray that the Land bounty promised a surgeon may be allowed them for the services of their ancestor from the 1<sup>st</sup> July 1776 to the 6<sup>th</sup> November 1783.
