Pension Application of Samuel B. Green R14649

VA Half Pay

[There is no application in the file, much of which consists of legal arguments with little detail regarding Green's service. The following is a sample.]

Washington City 11<sup>th</sup> of October 1844 Honorable Sir

The Claims of Capts Peter Moore [W25716] and Isaac Browning [R12796] and Lt Samuel B. Green has long been before you and appeal for a review and reversal of your decision or a Reference to the Attorney General on questions of law raised by you in your rejection of the 15th of June last. It is now well neigh four months since those papers have been before you. And upwards of three months since you have promised me to take up and reexamine those cases. At a more recent date I called to see you again when I was told to call when Mr Edwards [James L. Edwards, Commissioner of Pensions] had returned Before he returned you had left and thus those cases inconsiderable in themselves but of vital importance to the heirs have been a long time waiting your reexamination. As Mr Edwards has now returned and your honor also I have to ask that you will befriend me and the parties by causing a reexamination of those papers as early as practicable. I also hand you a communication or argument from Mr Moore relative to the claim which he represents

I certify that I have examined the claim of the administrator of Samuel B. Green, deceased, who was a Lieutenant in the regiment of Virginia State Troops commanded by Col. Crockett [Joseph Crockett S46377]. This claim for half-pay under the act of July 5, 1832 was allowed for service as an Ensign, whereas it should have been allowed for service as a Lieutenant, as it appears from the Report of the Board of Officers that sat at Richmond in April 1782 [see the Pension Application of Isaac Browning R12796] that he was entitled to promotion for the 2<sup>d</sup> of September 1781. The administrator is therefore in my opinion entitled to the difference between the half-pay of a Lieutenant and that of an Ensign, viz. forty dollars per annum from the first of March seventeen hundred and eighty two, to the twenty-ninth of July eighteen hundred and fifteen [the presumed date of Green's death], being the same period for which the original claim was allowed. William J. Stone, junior, Esq'r. of Washington City, is the administrator.

[From Virginia Half-Pay pension records on fold3.com indexed as Green, Samuel Ball. On 26 Sep 1833 in Frederick County VA several citizens certified that Samuel B. Green and Sarah B. Green were the only children of Samuel Ball Green and Elizabeth Green, that Samuel Ball Green had died, and that his widow, children and son-in-law, John Hollingsworth, had moved to Kentucky, where Sarah died. A letter by attorney Thomas Green (relationship if any unknown) dated 22 Aug 1850 states that Samuel B. Green lived in St. Joseph, Missouri, and John Hollingsworth in Iowa.]
