North Carolina Cumberland County: Court of Pleas & Quarter Sessions March Term 1834
On this the 5th day of March 80 1834 personally appeared before the court aforesaid
Duncan Campbell aged about seventy years a resident of the County and State aforesaid who
first being duly sworn according to law, doth on his oath make the following declaration, in order
to obtain the benefit of the provision made by the act of Congress passed June seventh, 1832.
That he enrolled in 1780 or 1781 – he is between impression – in the year 1781 in Captain
Thomas Hadleys Company, Colonel Robert Roan being drafted for three months and served the
same tour in and about Fayetteville North Carolina then Cross Creek in his service being to keep
the Tories down and to protect the Town and County – he was marched only from and about the
County and Town, this is the nature of the service and for this tour of three months he claims a
pension – The only service he performed in this tour first tour was to go to Bladen to assist in
raising some boats that had been sunk near Elizabeth in said County.

In 1782 he served under the same officers as a substitute for one John Campbell – this tour was of three months duration – the nature of this service was nearly to keep the Tories in all in and about Cross Creek in Cumberland County, being stationed at Cross Creek, in preparing Coal [probably charcoal] for Smith work and labor of that kind – for this tour of three months he also claims a pension – The next tour under the same officers, was in (he thinks the year 1783) two months before the declaration of Peace – in this he was a substitute for Farquaha Campbell. This tour he was stationed at Fayetteville then Cross Creek and performed an active service, safe as a protection to the Town and County. That he never was in any engagement – nor wounded in any way in the service – that he has no documentary evidence to prove his service – and that there is no clergyman from whom he can obtain a certificate. He expects to prove by Daniel McLellan (pensioner) under active 1832 – that he served for three months.



He hereby relinquishes every claim whatever to a pension or an annuity except the present and declares that his name is not on the Pension Roll of any Agency in any State –




