[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

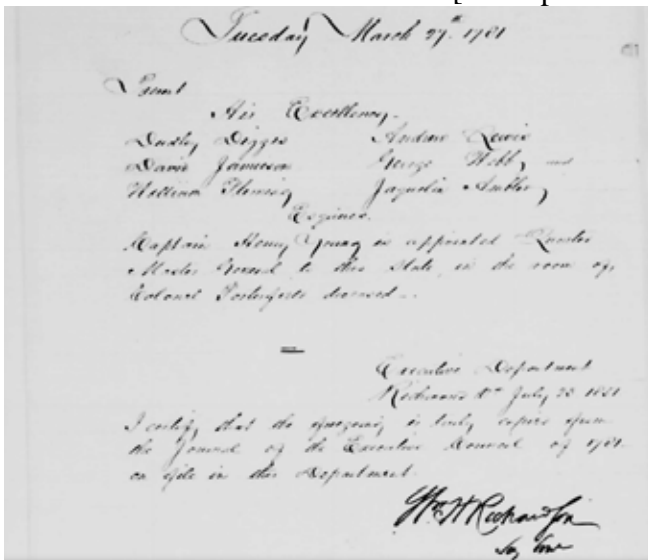

To the Executive of Virginia

The petition of the Heirs of Henry Young respectfully Sheweth that the said Young was on the 27th of March 1781, appointed Quarter Master General of this State, & served as such until the end of the war, & indeed, for some period after the close of the war until the accounts of the Quarter Master's Department were finally settled.

This service of Mr. Young is proved by the book of his accounts in the Auditor's Office & by numerous entries in the Council Journal from March '81 to the end of the War

And a quarter Master General being entitled to the rank of Colonel, as [indecipherable word]¹ by the usage of the Council Office & for [indecipherable word]² divisions of the executive, land bounty as Colonel is asked.
