Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

For the purpose of obtaining the benefits of the act entitled "An act for the relief of certain surviving Officers and Soldiers of the Army of the Revolution," approved on the 15th of May, 1828, I Richard Bass of the Revolution in the County of DeKalb in the State of Georgia do hereby declare that I enlisted in the Continental Line of the Army of the Revolution, for and during the war and continued in service until its termination; at which period, I was a private Soldier in Capt. Thomas Page ['s] Company, in the American Regiment, of the Continental Line. I also declare that I afterwards received certificates for the reward of eighty dollars; to which I was entitled under a resolve of Congress passed the 15th of May, 1778.

And I further declare that I was not, on the 15th day of May, 1828, on the Pension List of the United States.

That I served two tours of three months Each and that I have never received any pension from the United States either Personally or by Agent.

Witness my hand, this 16th day of May in the year of our Lord 1829.

The United States of America indebted to Richard Bass for services rendered in the revolutionary war against Great Britain in behalf of the United States of America while a citizen of Duplin County North Carolina during the revolutionary war services rendered as follows Served as Ensign one tour of three months in the years 1774 & 1775 at Wilmington North Carolina under the command of Colonel James Kineon [James Kenan] of North Carolina Duplin County the dates above as well as recollected --

2nd Also served as Captain afterward three months at Duplin Court House 3rd served do three months tour at Rockfish Bridge 4th served three months at N. East River Bridge 5th served three months tour at Wilmington and fort Johnston [Fort Johnson] in Brunswick at the Expiration of the last mentioned tour I resigned my commission as Captain 6th tour served two tours on scouting off three months each under the command of Colonel James Moore of Duplin County North Carolina as a private soldier and not having my Discharges that I was in possession of was and having my house plundered by the Tories while on Duty in my absence and robbed of my Discharges and my property taken the above statements is as near as my memory serves me at this time are just and true and never have received the first Dollar for my service yet.
