Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

For the purpose of obtaining the benefit of an act for the relief of certain Surviving officers and Soldiers of the Army of the Revolution approved on the 15th of May 1828 I Jesse Mobb of the County of Clark in the State of Georgia do hereby declare that I enlisted in the Continental line of the Army of the revolution, for and during the war, and continued in service until its termination, at which period I was a private in Capt. Allen's company in the fifth Regiment of the North Carolina line, and I also declare that I afterwards received a certificate for the reward of \$80 to which I was entitled under a resolve of Congress passed the 15th of May 1778 and I further declare that I was not on the 15th March 1828, on the pension list of the United States. Georgia: Personally appeared before me a Justice of the Peace for Clarke County and State aforesaid William McCallum¹ who being duly sworn saith that he has known Jesse Mobb of Clarke County State aforesaid since the year 1779 that he saw said Jesse Mobb enlist as a regular Soldier in the fifth Regiment of the North Carolina line on the Continental establishment in

¹ No one by this name filed for a pension from the federal government for services in the Revolution while in the NC Continental Line or as a resident of NC when he first entered the service.

Hillsboro in the month of September 1780, that he well knows the said Jesse Mobb enlisted for and during the War Served throughout the Same until he was disbanded at a place called South Boston on Dan River in the State of Virginia. Sworn to before me this 9th day of April 1829. S/ Jim Hanson, JP
